Message from CEO

The mushroom growth of non governmental organizations in recent years is a positive sign of vibrant civil society groups this reflects their commitment for marginalized segment of the society but harmonizing their efforts and resources was a challenge with perspective of integration of development initiatives. This prompted a group of development practitioners and professionals in the year 2011 aspiring for emergence of an organization which can serve as a catalyst for change process. All the founding members had a vision of an organization that



can ensure engaging the civil society organizations, public sector service providers and disadvantaged groups of communities at large with a motive of **better tomorrow for all** that led to the creation of ACT International.

The year 2012-13 was a formation to consolidation year for ACT-International, but it simultaneously kicked off its course of interventions soon after its emergence. Volunteer professional and dedicated founding members of the Act-International made strides even in this transition phase by carrying out vital projects ofsocial mobilization, youth development, environmental protection and advocacy for women and children rights. Working with key partners, the Act-International has delivered substantial support to the implementation of the programmes and the report showcases a difference in the lives of the people in the very first year of its emergence. It was an uphill task but the passion of the team backed by commitment and motivation made it happen.

In the first performing year ACT-International managed to establish close cooperation with many partners, especially Benazir Income Support Programme (BISP), Aurat Foundation and DFID for social mobilization as a specific area of the organization. We have been able to reach 19168 women beneficiaries in pilot project and currently working with 486,744. We have been able to host the highly represented National Youth Summit 2013, an august forum, which brought over 200 young leaders from across Pakistan that led to networking with a big number of youth focused organizations including Valley Trackers, Plan International, Hashoo Foundation, Bargad, Change Thru Empowerment, NAWADO, RDF, SAFWCO and School of Leadership (SoL). On the environmental side, ACT entered into partnership with Nekatrina, a Zagreb-based organization advancing the environmental goals across the world. We have been able to develop partnership with EPA-AJK, ECO and UNDP for environment through education 4 sustaniability. We are also exploring opportunities to initiate on our other programme areas and the spade work has been completed to net many others organizations.

We are present in the major parts of Pakistan as we have offices in Islamabad, Muzaffarabad, Charsadda, Mansehra, Peshawar, Benazirabad, Gawadar, Jhal Magsi, Mirpur and Bagh, AJK with a staff strength of 150, comprising of 16 managers, 128 professionals and 6 support staff, with a healthy mix of men, women, experienced and young professionals.

On behalf of the Board of Directors, I would like to thank the volunteer founding members of ACT International for their dedicated leadership through the year. Simultaneously, thanks are also due to the whole team of Act-International including professionals and volunteers. The success achieved in the previous year would not have possible without the support of this hardworking and efficient team. We hope that initiatives gained in the last year would be capitalized in the next years. We pray for a productive year ahead.

THE GENERAL BODY

The Organization shall in each calendar year hold a general meeting as the Annual General Meeting, in addition to any other meetings in that year, and shall specify the meeting as such in the notice, calling it within a period of six months following the close of its financial year. Not more than fifteen months shall elapse between the date of one Annual General Meeting of the Organization and that of the next. The Annual General Meeting shall be held at such time and place, as the Board shall specify.the above-mentioned meetings shall be called Annual General Meetings and all other General Meetings shall be called Extraordinary General Meetings.The Board may, whenever it thinks fit, convene an Extraordinary General Meeting.There are twenty five members in the general body of Act International

BOARD OF DIRECTORS/EC

The Board of Directors, subject to the general control and supervision of the General Body shall generally pursue and carry out the objects as set out in the Memorandum of Association of the Organization. The Board of Directors shall be responsible for the management and administration of the affairs of the Organization in accordance with these Articles of Associations. The affairs of the Organization shall be managed by a Board of Directors, which shall have the responsibility to determine the direction and scope of the activities of the Organization. It shall also have the responsibility to approve projects and ratify grants, donations, loans or other financial assistance from different relevant sources and to approve and administer the annual and supplementary budgets. The number of Directors hold on 08. there are eight elected members of the BoD.




Social Mobilization and National Cash Transfer Programme (SM NCTP)

The Benazir Income Support Programme has designed a conditional cash transfer program, called *Waseela-e-Taleem*, funded by DFID and the World Bank. The objective of this program is to provide conditional cash transfers to BISP recipients to ensure that their children are enrolled and regularly attend primary schools and retain children who are already in school. Aurat Foundation and ACT International, in the pilot phase of Social Mobilization, National Cash Transfer Programme under the BISP had carried out the project in 5 districts. On the basis of pilot test, the project was rolled out in 20 districts as an extended phase. The following pie charts are reflecting the progress of the project.

During the pilot phase of Social Mobilization, National Cash Transfer Programme (BISP), mapping of 19,168 women beneficiaries has been done in 5 districts against a target of 22,446. Details are given in Chart 1.



Similarly 811 BBCs (Women Committees) were formulated commutatively in all districts, Chart 2 reflects the segregation.



Key Achievements

During the project period from 6th August 2012 to 28th February 2013, the following are the main achievements of the project:

- IEC material has been developed and disseminated in all selected Tehsils.
- The mapping of the 22,446 BISP Beneficiary have been completed
- 220 area opening meetings have been held, and 752 BISP Beneficiary Committees (BBCs) have been formed against the agreed target of 657 BBCs.
- A total of 3461 BISP Beneficiary Committee meetings attended by SOs and 51 BUCCs meeting organized and six BTCCs meetings conducted.
- Capacity building training modules and an Awareness Sessions Handbook for SO's has been developed and distributed to field teams.
- Social Organizers have delivered 1957 awareness sessions in the committees
- A total of 790 women leaders have been imparted one day orientation training by organizing 24 training events against the agreed target of 657 Women leaders. The comprehensive training report is produced and shared with concern stakeholders.
- A total of 37 Union Council Committees have been formed against the total target of 20 and trained 37 UC councilors on process and documentation of UC committees and role/responsibilities of councilors in newly formed UC committees.
- Six BISP Tehsil Coordination Committees formed in all six thesil of five selected districts
- The detailed Calendar of BBCs meeting and Women Leaders Contact directory has been developed for all five districts and shared with concern stakeholders.
- Six district consultation workshops of stakeholder organized and findings and suggestions are documented in a brief report and incorporated in the final draft of social mobilization strategy.



Youth Development Programme

ACT-International's YDP key activities are:

National Youth Summit 2013



National Youth Summit 2013 was a joint venture of Aiming Change for Tomorrow (ACT) International and Valley Tracker (VT). Theme of NYS was "Let's Visualize Change Together", which depicts the precursor and phenomenon of change.

Objectively National Youth Summit was organized to enhance leadership capacity, build confidence, introduce the youth to the social challenges, inculcate responsibility, ensure intercultural & interfaith harmony and provide an opportunity to network with the youth around the country. The summit brought 200 young people from all around the country to the city of Muzaffarabad for a four-day residential event, which was addressed by Sardar Muhammad Yaqoob Khan President of AJK, SardarAttique Ahmed Khan President Azad Jammu & Kashmir Muslim Conference, ShaheenKausar Dar Deputy Speaker AJK Assembly, members of the cabinet, MLAs, peace activists, journalists, civil society representatives and intellectuals.

An NYS'13 resolution was also passed by the Youth of Pakistan asking the government to impose a youth emergency in Pakistan, conduct pro-youth reforms for job creation and bring uniformity in educational system and the syllabus across the country with immediate effects. The demand was made during the National Youth Summit 2013 in Muzaffarabad through a voted resolution.



Environment

Education 4 Sustainability (Environment)

ACT International is currently implementing 'Education 4 Sustainability' project with the cooperation of Nektarina, a Non Profit based at Zagreb, Croatia.. The overall goal of the project is to garner the support from public and private sector stakeholders in Pakistan for integration of sustainable development subject into existing curricula of pre-university levels. The project is focused on engagement, increase responsiveness and enhancing the capacity of the key influencers and policy makers at the national and provincial levels to ensure availability of services and focusing on the awareness raising, knowledge sharing and building constituencies at the district and community level to generate demand and catalyse sustainability and continuity.

The prilimanry phase of the project is being implemented. The major components of the project included Assessment, consultations with the government quarters both at the centre and provincial levels; private sector (potential NGOs, media, celebrities etc.); Formation of committees and caucuses; Seminars, workshops, discussion forums and ICT material; school - based activities at federal, provincial and district level; generating position paper on sustainability on education; and mustering support of decision makers and policy makers for introducing the sustainability in education in the national curriculum.



Festival 4 S

With an aim to highlight the environmental issues, ACT International organized a mega "Festival 4S: Save Environment, Save Planet, Save Life & Save future in Muzaffarabad, on June 5 and June 6, 2013. Environmental Protection Agency (EPA-AJK) and Environmental Conservation Organization (ECO) were the partner organizations.

Environmental Protection Agency (EPA-AJK); Municipal Corporation Muzaffarabad (MCM); Department of Forest (AJK); Department of social welfare & Women Development; Department of Agriculture; Department of Livestock; Department of Wildlife; Department of Tourism; Pakistan Red Crescent Society;

UN Women; Kashmir Handicrafts; Women Foundation; Pakistan Photojournalists; Fauji Foundation Schools; Roots School System; Post Graduate College for Women; University of AJK particpated in the event by setting up their stalls.

A printed pledge both in English and the local language was got signed from the a large number of visitors. A 100 meter long mural was an important feature of the Festival 4S that was put on a rostrum in the venue of the festival for signing of visitors and dignitaries. Cabinet ministers, senior government officials, UNDP Pakistan's Country Director, educationists, environmentalists and visitors signed the mural.

A seminar was also organized ahead of opening of the festival which was attended by half a dozen ministers, senior officials and UN representatives, experts and elites of the city. The concluding ceremony was later graced by Senior AJK Minister Chaudhary Yasin.




Advocacy

ACT International envisions communities to be prosperous, vibrant, cohesive and ready to face the challenges of the future. Such goals are sustainable only through grassroots support.









Audited Financial Statements and Financial Results

Developing Policies and Procedure

During the last over one year, ACT International's Board of Directors and the top management underwent a tedious process of revisiting all its policies, practices, programmes and projects for ascertaining its strengths, weaknesses, opportunities as well as threats. In addition to SWOT analysis, an overall environment analysis took place with a top-down approach instead of the bottom-up approach. In the aftermath of the environment analysis, the organization decided to hire a team of highly professional and technically sound and expert consultants with a proven track record of providing top-notch consultancy to both similar organizations as well quite a few large for-profit organizations. The organization has been able to frame policies and rules on all the vital components that are being adhered in true letter and spirit to ensure good governance.

INDEPENDENT AUDITORS' REPORT TO THE MEMBERS

We have audited the accompanying financial statements of **AIMING CHANGE FOR TOMORROW (ACT) INTERNATIONAL** ("the Society"), which comprise the balance sheet as at 30 June 2013, the income and expenditure statement, and a summary of significant accounting policies and other explanatory notes.

Management's Responsibility for the Financial Statements

The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the Society's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.
